Sophomores, juniors, and seniors must meet the district’s 1.0 credit technology requirement for graduation. They may successfully complete two semester courses of any of the variety of available qualifying technology classes. Students may also waive 0.50 credits of the graduation requirement by successfully completing a technology proficiency exam administered by eAcademy.

Starting with the class of 2022 only 0.50 credits of Technology will be required. This exam is not open to students graduating in the year 2022 or later.

The exam consists of 3 components: one set of objective questions and two performance/skills sections. To meet the technology requirement by exam, students must obtain an overall score of 75% or better on the exam, based on a simple percentage of points earned from points possible. The exam may be retaken once.

Successful completion of the exam fulfills 0.50 credit of the Olathe District technology requirement for graduation. *It does not decrease the total number of credits (24) required for graduation; neither credits nor a grade are awarded for the exam.* Completion of the technology requirement will be noted as a waiver on the student’s transcript.

The exam is administered at the Instructional Resource Center. There is no cost. The exam is completed in one sitting and students should allow up to 4 hours for completion. The exam will be scored within a week of its completion and results will be reported in writing to the student and student’s counselor.

Students may register for the exam by completing the form below and returning it to their counselor or eAcademy.
